# 1. Introduction

T7 operates the on-exchange trading functionality of the Cash Market exchange. The Trading Venues Börse Frankfurt including Börse Frankfurt Zertifikate (BFZ) migrated to T7 on August 24, 2020. The term "Börse Frankfurt" is used in the subsequent sections for Börse Frankfurt and Börse Frankfurt Zertifikate if not explicitly differentiated.

As a result, this document will cover both, Xetra and Börse Frankfurt. It is clearly mentioned in this document if a functionality, role, feature etc. is valid only for one market. Otherwise, it is relevant for both.

Service Administrators can add and maintain users via the Graphical User Interface (GUI).

This includes the maintenance and restriction of access to products, functions and entitlement, the order and quote volumes as well as the scope of orders, i.e., which orders can be acted upon.

# 1.1 Purpose of this Manual

This manual is intended to assist service administrators with maintaining participant and user related data in the T7 system.

The following areas are covered:

- Explanation of fundamental concepts regarding Member/User/Entitlement.
- Pre-defined user roles (e.g., Cash Trader).
- Maintenance processes by service administrators.
- TES Type Eligibility

In some areas, only a short description of a functionality is given. For further details, please refer to the documents mentioned in next chapter.

#### 1.3 What's new?

This chapter shortly describes new/changed functionalities which have an impact on entitlement.

For detailed information of the functionalities themselves, please refer to the "Functional/Technical Release Notes" and/or the "Functional Reference" document.

Please be aware, that this document includes the Trading Venues Xetra and Börse Frankfurt (Zertifikate). It is mentioned if something is only valid for one of the Trading Venues. If nothing is indicated, the information is relevant for both.

A detailed description of the Admin GUI including screen prints can be found in the "Trader, Admin and Clearer GUI Manual, chapter 4.2.6 "User Maintenance".

#### Pre-Trade Risk Limits based on the Notional Value (Xetra only)

With T7 Release 11.0, the Pre-Trade Risk Limits (PTRL) functionality will be introduced for on-book trading in the trading venue Xetra to improve risk management capabilities of Xetra trading participants for CCP cleared products.

The PTRL functionality will allow trading participants, clearing members and the exchange to set limits for the daily maximum notional value of all entries, modifications and executions of orders and quotes per product and trading side. The setting of the PTRL by the exchange, clearing member, and trading participant is referred to as *PTRL Definition*.

The roles *Pre-Trade Limits* and *Pre-Trade Limits View* will be assigned automatically to all existing trading business units for Xetra.

The roles *CM Pre-Trade Risk Maintenance* and *CM Pre-Trade Risk View* will be assigned automatically to all existing clearing business units for Xetra.

The View roles will enable users to view existing limits, the other roles will enable the maintenance.

All participants intending to use Pre-Trade Risk Limits need to assign the roles afterwards to their users, beginning on day 1 of T7 Release 11.0.

The PTRL limits will be maintained via ETI or via GUI. Clearing members will define the limits for their non-clearing members via the T7 Clearer GUI. Participants will define the limits for their user risk groups via the T7 Admin GUI.

# 2. Concepts

This chapter describes the fundamental concepts in T7 regarding products, participants, users, entitlements and risk limits.

## 2.1 Products / Product Assignment Groups

T7 includes a hierarchy containing product assignment groups, products and instruments. Instruments are the tradable entities, i.e., an order always refers to buying or selling a specified quantity of a certain instrument. Instruments of the same type can be grouped together to form products. However, every tradable instrument must belong to a product. Instruments of the same product are traded in the same way, i.e., trading parameters and trading schedules are defined for products rather than for individual instruments. A product is always associated with a product assignment group, which is used for entitlement and can be assigned to multiple product assignment groups simultaneously.

Deviating handling for Börse Frankfurt: In contrast to the PAG usage in the continuous trading model, where the PAG serves as a means for the entitlement, e.g., for a user's trading permission in relation to PAGs, the PAGs in "Continuous Auction with Specialist" trading model and "Continuous Auctions with Market Maker" trading model do not govern entitlement, e.g. all users can trade all instruments of Börse Frankfurt and Börse Frankfurt Zertifikate, if the Cash Trader role assignment is granted. PAGs are only used for the logical grouping of products.




Image 1: Product structure

## 2.2 Participant Structure

The participant is an entity in T7 representing the member legal firm. Within a participant, different units may exist that act independently from each other. These are so called Business Units (BU). There are two different types of BUs:

- Trading Business Unit
   A trading BU is necessary in order to participate in trading.
- Clearing Business Unit
   A Clearing BU receives trade notifications for the trades of the own trading BUs, as well as for the trades of the trading BUs of related NCMs. Additionally, the Clearing Member Stop functionality can be granted by the exchange to the Clearing BU.

A BU is represented by a business unit name, e.g., ABCFR in case of a trading business unit. For clearing business units "CL" is appended to this ID, i.e., to ABCFRCL to be able to distinguish both IDs easily.



Image 2: Participant structure

Participant data is set up and maintained by Deutsche Börse. The participant is authorized to a market (e.g. XETR). Currently in T7, a participant can have up to two pre-defined business units. Trading members have one business unit designated for trading. Clearing members have one business unit designated for clearing. Clearing business units can receive all on-exchange trade notifications from every trading member for whom they are the designated clearing member. If a member performs trading as well as clearing operations, he will have one trading and one clearing BU. Cash Market distinguishes between settlement institutes and central counterparty (CCP) clearing members. While CCP clearing members only receive on-exchange trade notifications in CCP-eligible instruments, settlement institutes receive all trade notifications, including trades in non-CCP-eligible instruments.

Trading members can choose to not use their agency account.

Every business unit has a business unit short name (e.g., clearing business unit "ABCFRCL"), as well as a unique numeric business unit ID.

#### 2.3 Users

A user is a person, such as a trader or a service administrator that interacts with the T7 system. A user may also be a machine, for example an order routing or quoting system. Every user of T7 belongs to exactly one business unit. It is not possible to assign the same user to multiple business units. Since trading and clearing business units generally fulfil different tasks, the entitlement will deviate also.

Service administrators define a user short name (e.g., TRD001). The user short name is unique on participant level, i.e. a user cannot have the same short name as another user, even if they are assigned to different business units. For example, if there is a user with user short name "TRD001" under the trading BU, it will not be possible to create another "TRD001" neither under the trading BU nor under the clearing BU of the same participant. Combining the participant ID (e.g., "ABCFR") with the user short name (e.g. "TRD001"), a user login name (e.g. "ABCFRTRD001") is generated, for use in the new Admin, Trader and Clearer GUIs.

Users have to be assigned to a user group. At least one user group has to be defined. Multiple user groups within the same business unit are optional. For example, user "TRD001" can be put in user group "ABC" (name of user group can be different to the first three digits of user ID). A user group is created automatically, when the first user is assigned to it.

T7 provides a PIN code functionality on user level. For each user an own PIN code can be entered in the system. It is not mandatory required, as this is an optional field. PIN codes can be used to authorize the appropriate user at Deutsche Börse via telephone in order to perform risk control operations, such as an emergency mass deletion. Users can view their own PIN in the login window of the GUIs. It is important to note that users, who are assigned the Service Administrator role or the User Data View role, are also able to see the PIN codes of all other users within the same business unit.

Changes to user attributes or entitlement are applied immediately. The user should log out and log in again to enable changes.

#### 2.4 User Roles

The T7 system provides a set of pre-defined user roles, configured and maintained by Deutsche Börse. User roles offer participants a simplified approach to administration:

- Sets of resources (e.g., Add Order) are combined to define a logical user role (e.g., Cash Trader).
- A participant assigns roles to users, and multiple roles can be assigned to the same user (multiple user IDs are not needed).
- A user is granted entitlements for specific roles for specific product assignment groups (see 2.5) or, in case of Börse Frankfurt, for the complete market.

Refer to section 4 for the complete set of pre-defined user roles available to participants.

The following diagram is an example of the user role concept, showing that a subset of all available resources (on the left) is selected to form a role (trader role on the right):




Image 3: Combination of resources to roles

#### 2.5 Entitlement

Participants entitle users for specific user roles for specific product assignment groups. In contrast to the PAG usage in the continuous trading model (Xetra), where the PAG serves as a means for the entitlement, e.g., for a user's trading permission in relation to PAGs, the PAGs in "Continuous Auction with Specialist" trading model (Börse Frankfurt) do not govern entitlement, e.g., all users can trade all instruments of Börse Frankfurt and Börse Frankfurt Zertifikate, if the Cash Trader role assignment is granted. PAGs are only used for the logical grouping of products.

The following diagram shows some example combinations of entitlements:




Image 4: Entitlement structure

For example, user TRD001 has a supervisor user level and has been entitled to the *Cash Trader* role for product assignment group 1 as well as *Emergency Trading Stop* and *User Data View* roles for the entire market. User TRA056 has been entitled to the *Cash Trading View* role in product assignment group 1 and the *Cash Trader* role in product assignment group 2.

Participants can assign users to more than one role, however certain restrictions apply that are described further in section 4.

## 2.6 Maximum Order Value (Trading business unit only)

The Maximum Order Value (MOV) is an optional parameter, which defines the maximum value of an order or quote that a trader is allowed to enter. The value of each incoming order side is compared against this limiting parameter and the order is rejected in case the limit is exceeded. The value of the order is calculated as quantity times limit price for buy limit orders (last trade price or the respective reference price for buy market orders). The MOV is stored in exchange currency, i.e., in case of orders in a foreign trading currency instrument, the respective exchange rate needs to be taken into account.

Maximum Order Value = Quantity \* Limit Price of order

(Remark: Limit Price is the price in trading currency. T7 will convert the respective price using actual exchange rate)

For sell side orders (limit and market), the last trade price or the respective reference price will be used. Stop orders will be validated based on their trigger price.

One Cancels the Other orders will be validated based on their limit price. Iceberg orders will be validated with the full order quantity, refills of Iceberg orders are not relevant for the validation.

Volume Discovery Orders will be validated with the full order quantity and for buy side orders with the Volume Discover Price (the second limit of the Volume Discovery Order).

Note that the functionality described above applies for quotes as well, if not explicitly stated otherwise. For instruments traded in percentage the formula applies *ceteris paribus*.

MOV for a specific user is maintained by the participants themselves, using the Admin GUI. Since this is an optional field, it is not required to enter a value. In this case, the user will not be able to enter orders and quotes.

Maximum Order Value check for TES: This check is in place for on-exchange trading as well as for TES trading. On entry, the TES price multiplied with the TES trade quantity has to be lower or equal to the Maximum Order Value given on the user level. If the validation fails, then the TES trade approval will be rejected for the corresponding approving user. Valid only for TES Type "LIS", no validation for TES Type "OTC". Check is applied during approval of TES trades.

#### 2.7 Maximum Order Quantity

One MiFID II requirement for pre-trade controls for cash markets is the maximum order quantity validation, which prevents orders with a too large order size from entering the order book.

Participants will be able to maintain the maximum order quantity limits for their users intraday and the changes will be effective immediately. The maximum order quantity will be set on user level, meaning one limit per user. The validation can be skipped for orders and quotes entered via ETI and FIX gateways

if the user wishes this explicitly. Orders entered via the T7 GUI are always subject to maximum order quantity check.

The total order quantity or the modified total order quantity will be validated against the maximum order quantity. Any previously matched partial execution will not be taken into account. If the order modification will lead to a maximum order quantity violation, then the modification request is rejected, and the initial order remains in the order book.

Iceberg orders will be validated with the full order quantity when entering the order book, refills of Iceberg orders are not relevant for the validation. Volume Discovery Orders will be validated with the full order quantity.

Maximum Order Quantity check for TES: This validation is part of on-exchange trading as well as TES trading. The pre-defined Maximum Order Quantity on the user level has to be lower or at maximum equal to the TES trade quantity. It is valid only for TES Type "LIS", there are no validation for TES Type "OTC". The check is applied during approval of TES trades.

## 2.8 Trading Capacities

Whenever a user enters an order or quote, it has to be entered for a certain trading capacity.

Five different trading capacities will be supported for the cash markets on T7:

- A Agent Account
- P Proprietary Account
- M Market Making Account
- R Riskless Principal Flow Account
- I Issuer (only possible for quotes)

The different trading capacities can be granted or revoked from a user independently of each other in the Admin GUI.

The Trading Capacity is named "Accounts" in the T7 Admin GUI.

#### Please note:

- For entering quotes in the "Continuous Trading with Auctions" trading model, the user needs the trading capacity "Market Making" as well as the entitlement role "Cash Market Maker".
- For entering quotes in the "Continuous Trading with Specialist" and "Continuous Trading with Market Maker" trading model, the user needs the trading capacity "Issuer" as well as the entitlement role "Cash Specialist".
- If the user is acting as issuer, the trading capacity "Issuer" as well as the category "Quote Provider (7)" are necessary.

## 2.9 User Levels (Scope of Orders, for Trading business unit only)

## 2.9.1 On-exchange trading

Every user is designated to have one (and only one) user level: trader, head trader or supervisor. The user level defines which orders they are authorized to act upon (scope of orders):

User Level	Scope of Orders
1 - Trader	View, modify and delete own orders only.
2 - Head Trader	View, modify and delete own orders, as well as orders entered by other users of the same user group.
3 - Supervisor	View, modify and delete own orders, as well as orders entered by other users of the same business unit.


An order entered into T7 belongs to the entering user. If a second user changes this order, the ownership of this order will transfer to the second user. Only exchange Cash Market Operations can enter an order on behalf of another user.

Contrary to the ownership and scope of orders, a quote is owned by the session instead of the user. A session may enter only one quote per instrument. Sessions belonging to the same business unit may have different quotes in the same instrument, but only one quote per instrument per session is allowed. When a new quote is entered by the same session for the same instrument, the old quote will be overwritten. Based on the entitlement, a user may overwrite, modify or cancel any quote of another user that is owned by the same session.

In context of orders, the order attribute defines the order visibility. While standard orders can be viewed, modified and deleted by other sessions within the same business unit, lean orders cannot. For further information, please refer to the document "T7 Enhanced Trading Interface – Manual incl. Repository and Header files".

Participants define the user structure themselves, reflecting their business operations and practices. One or more supervisors can be defined, who are entitled to perform actions for the entire trading business unit.

Please note that users can only act upon orders in product assignment groups for which they are entitled, regardless of their user level (entitlement overrides user level), see 2.5.

# 2.9.2 TES functionality

#### 2.9.3 Xetra EnLight

This functionality is only available for Trading Venue Xetra.

The behavior for Xetra EnLight is slightly different to the one for on-exchange trading.

A user level is a mandatory user attribute which determines a user's right to perform Xetra EnLight maintenance actions for other users from the same business unit or from the same user group:

## 2.9.4 QP User (relevant for Börse Frankfurt only)

It is mandatory for each Trading Business Unit (acting as issuer or specialist) to have at least one user set up according to the following schema:

A user acting as quote provider for a particular instrument needs the following setup:

- a. The category "Quote Provider (7)"
- b. The trading capacity "Issuer" (as Issuer or Specialist)
- c. UserGroup has to be named "QPR" for Issuers or has to start with "QP" for Specialists

This setup is required to identify the legally binding user for each trade resulting from matching quote execution of the specialist.

In case more than one user is set up as shown above, Börse Frankfurt will use the first user (in alphanumeric order) as the one who will be reported in the Trade Notifications.

This user has to be linked to an active trader admitted to trading on Börse Frankfurt (this has to be ensured by the member).

# 2.9.5 Non CCP Trading

Cash Service Administrators can define whether a user is allowed to trade non-CCP instruments on-exchange in the User Maintenance view of the T7 Admin GUI.

The flag *allowNonCCPTrading* on user level is evaluated during each order entry for a non-CCP instrument. In case it is set to false, no order entry or modification will be possible.

## 3.8 TM Trade Overview (TM is used for Trading Member)

# 3.9 Emergency Trading Stop

The emergency trading stop role enables risk control functions to stop trading for a user or the entire business unit, and automatically delete orders and quotes. In order to give this role to a user it is required that this user has the level set to 'Supervisor'. Without the Supervisor level, it will not be possible to grant this role. # 3.10 Emergency Mass Deletion

### 4. TES Type Eligibility

The TES Type Eligibility on T7 is used to control access to the various TES Types

- LIS (only Xetra)
- OTC
- Xetra EnLight (only Xetra)

TES Type Eligibility is set on participant level and on user level.

The participant level assignment is done by the Exchange. Every participant is enabled to use all available TES Types of the respective market (trading venue).

The service administrator can then assign the TES Type Eligibility to the user. This is done in the GUI, using the User Maintenance screen.

### 5. Maintenance

This chapter describes the maintenance functions that will be performed by service administrators.

Data related to product assignment groups, participants, business units, users and risk controls will be made available to service administrators, including all identifiers needed for all interfaces.

### **5.1 Product Assignment Groups**

Product assignment groups are created and maintained by Deutsche Börse.

### 5.2 Participant and Business Unit

The participant and business unit structure is created and maintained by Deutsche Börse.

#### 5.3 Users

This section describes the steps necessary to maintain users of T7.

Authorization can be configured by service administrators, as follows (T / C indicates if relevant for Trading or Clearing business unit):

### 5.3.1 Adding a user

Service administrators are able to add users themselves, according to the following steps:

#### 5.3.2 Modifying a user

Using the Admin GUI, service administrators may modify user information. If a non-trading user is updated to become a trading user, there must be a trader admission, see 5.3.1, step #1.

Modifications to the user attributes (MOV, entitlement, user group, user level and password resets) are effective immediately. Users must log out and then log back in for these changes to take effect.

#### 5.3.3 Password Rules

User password requirements for T7 are:

- minimum of 8 and a maximum of 16 characters
- valid characters: [a-z, A-Z, 0-9] and special characters: ['+', '-', '@', '!', '\_', '\$', '%', '&', '/', '=', '\*', #']
- minimum 1 uppercase letter and minimum 1 lowercase letter
- minimum 1 special character
- maximum number of repeated characters allowed is 6
- a password history is maintained to prevent the last 10 passwords from being re-used.

User passwords do not automatically expire. Users are able to change their passwords themselves. Passwords can only be changed using the GUI. Passwords generated during setup of new users and passwords generated during password reset by Service Administrator will automatically expire after first login. The user is then forced to create a new password. Participants are responsible for the regular refresh of user passwords, according to their own security guidelines.

The two reports RD110 *User Profile Maintenance* and RD115 *User Profile Status* show any changes of a User PIN respectively the status of a User PIN without disclosing the PIN itself.

- Report RD110 User Profile Maintenance: On any change of the PIN, the fields audtValBefore and audtValAfter will be filled with "\*\*\*\*", and the field updtFldNam will contain "pinCode". Only when the PIN is defined for the very first time, the field audtValBefore will be filled with spaces.
- **RD115 User Profile Status**: There will be a new field *pinCode* of format alphanumeric 4. If a PIN is set, it will display "\*\*\*\*". If no PIN is set, it will display spaces.

#### 5.3.4 Deleting a user

Service administrators may delete users, according to the following steps:

#	Task	Description
1	Notify Exchange	Deutsche Börse should be notified of all user deletions. This is required for all trading and non-trading users, using the eXAS tool. This step is not applicable for simulation users.
2	Delete user	User deletions are done using the Admin GUI and are effective on the next day (but user login is prevented immediately).

Before deleting a user, participants should ensure that there are no open orders remaining in the system that were entered by this user. Any open orders for deleted users are automatically removed at the end of the trading day.

Participants are responsible for immediate deletion of a user account, when the associated person is no longer with the organization.

#### 5.4 Risk Controls

T7 provides several risk control functions for participants, which allows them to stop a user or an entire business unit from trading. In addition, clearing members are also able to stop one or more of their related trading members. Stopped users can continue to view trading activity but are not able to enter new orders or quotes.

Please take into account that stopping and releasing a BU/User requires two users (4Eyes Principle), both with emergency trading stop role, to execute the function. In case the second user does not approve the transaction, it will not be deleted during the nightly end-of-day run. It remains in the same status (Waiting for Approval).
